In accordance with art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016.

The exercise of the aforementioned rights is subject to the limits, rules and procedures established by the GDPR and that the interested party must know and implement. In accordance with the provisions of article 12 paragraph 3, moreover, the Data Controller will provide the data subject with information concerning the action taken without undue delay and, in any case, no later than one month after receiving the request. This deadline may be extended by two months if necessary, taking into account the complexity and the number of requests. The Data Controller informs the interested party of this extension, and of the reasons for the delay, within one month of receiving the request

This information may be subject to changes and / or additions, also as a consequence of the applicability of the GDPR and of any future changes and / or regulatory updates.

The updated information is constantly available on the website of the Owner.

The personal data provided may be processed by the Data Controller with and without the aid of IT tools. We also inform you that the communication of your personal data for the mandatory purposes indicated is a legal or contractual obligation or a necessary requirement for the execution of the contractual obligations, therefore you are obliged to provide your personal data, because in default it will not be possible to manage the relationship with the company.
