Right to contact the Guarantor for the protection of personal data (Article 77)	Without prejudice to any other administrative or judicial appeal, if you consider that the processing that concerns you is in breach of the personal data protection regulation, you have the right to lodge a complaint with a supervisory authority, particularly in the Member State in which you normally reside , work or the place where the alleged violation occurred.

The Data Controller informs the interested party of this extension, and of the reasons for the delay, within one month from receipt of the request.

The exercise of rights is, in principle, free; the Owner reserves the right to request an expense contribution in the event of manifestly unfounded or excessive (even repetitive) requests.

If the Data Controller has reasonable doubts about the identity of the individual submitting the present application, he may request further information necessary to confirm the identity of the data subject.

I am informed that the data indicated in this form are used exclusively to provide feedback to the requests and will be kept for 5 years, in order to ensure appropriate proof of the proceedings, for any exercises of rights in administrative or judicial.
